Explanatory Note: This Amendment No. 3 (this "<u>Amendment</u>") to the Schedule 13D relating to BlueLinx Holdings Inc. (the "<u>Issuer</u>"), filed by the Reporting Persons with the Securities and Exchange Commission on April 15, 2019, as amended and supplemented by Amendment No.1 to the Initial 13D filed on May 21, 2019, and as further amended and supplemented by Amendment No.2 to the Schedule 13D filed on June 10, 2019, amends and supplements certain of the items set forth therein.

As used in this Amendment, the term "Reporting Persons" collectively refers to:
